

## HEALTHCARE PLATFORMS OF THE TOP DEMOCRATIC PRESIDENTIAL CANDIDATES: A COMPARISON

Healthcare remains a pressing concern for voters heading into the 2020 presidential election. Throughout the 2020 primary cycle, the leading Democratic candidates for president have put forward detailed policy proposals for expanding healthcare access and affordability. Now, two leading candidates remain: Senator Bernie Sanders and Vice President Joe Biden. While their healthcare platforms are similar in some areas, they differ in important respects.

The table below offers a broad overview of Sanders' and Biden's healthcare platforms, based on information drawn from the candidates' official campaign websites. As of March 3, 2020 (Super Tuesday), these two candidates have the highest national polling averages.
